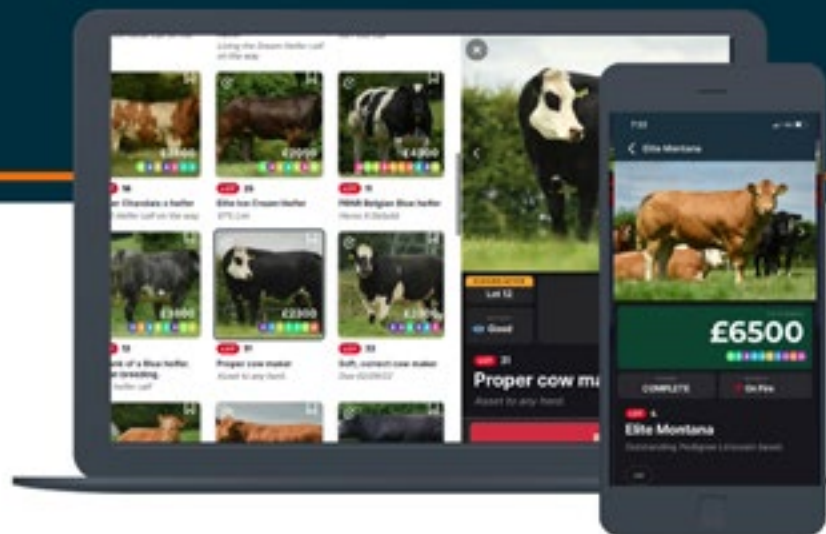

## **BOOTHFERRY FLOCK**

### **C D Timm**

The flock was established in 1970. I started work as a shepherd boy for the Croxton flock of W Blakeborough and sons, Lincolnshire. The flock had been founded with most of the sheep being purchased from the Benacrea and Lawshall flocks. In 1976 the Croxton flock was dispersed I decided to buy 1 particular family, paying a then world record price for the top ewe of 1260gns and an average of 1080gns for the 5 sheep. The family has been kept to this flock never losing any females out for sale. Our aim has always been to breed good Kelso type rams: with good colour, strong shoulders and fleshy. The flock has been based in the Scottish Borders and Yorkshire all its existence.

In the early years the flock was shown with great success. Highlights being at the Royal Show with successive years of 1988/1989 winning breed and interbreed championships. Also winning at all the major shows in the Borders. for a time showing was put to one side to concentrate on breeding more shearling rams and developing the farm business. Some of the highlights of the 1980's were being Champion flock in the Northern region twice. Topping Kelso ram sale with the highest average pen for any breed and top price of the day.

The flock has embarked on 3 female production sales - first on farm in Scotland at which 112 females averaged £980, second in Lancaster 5 years later 140 females averaged £1,080 and the third being a private sale that was conducted with the help of H&H sold 1510 Suffolks in one consignment to gross £225,000 for export to Romania. We have exported sheep to 11 European countries over the years to stress the foundation family has always been kept at home to retain the breeding. We then worked at breeding the flock back up to where it is now. Last year we felt the females were as good as if not better than the Royal show years, so we decided to try our hand again at the show. We went to Moulton show with 3 of our best gimmers where they won breed champion and in the interbreed under a well renowned continental judge they stood Interbreed champion to a great claim by the judge. The flock has had success in the Fatstock shows including Native champion pair at Smithfield 2020. We believe the females in the sale will breed to any sire and that the youngsters of today will be able to move forward in any direction with success with these sheep.

Over the last 10 years, 256 shearling rams have been sold to average £897. In 2023 the average shearling ram sold for £950 to top at £1,950.

We have made the decision to sell the flock now as we have to concentrate on our other ventures, cattle, sheep and butchers shop. Age is telling so feel it is time to let the flock move onto pastures new and new horizons.

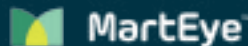
